3. Complete the 2023-24 Texas Application for State Financial Aid (TASFA) available for download from www.collegeforalltexas.com (Funds must be converted to US dollars using the current exchange rate.)
4. Collect copies of 2021 W-2s and tax returns for yourself and, if you are a dependent student, for your parent(s) also. If tax returns weren't filed, please submit a copy of 2021 W-2s or, if a 2021 W-2 was not received, please report wages on Question 70 of the TASFA.
5. If a transfer student, provide academic transcripts from all schools attended and request to have them evaluated at the Admissions Office. If you have taken classes at foreign schools, you must have the transcript evaluated to indicate the highest level of education attained. Please contact the Admissions Office for more information on third party evaluation services.
6. Return this grant application, income documents, and the TASFA to the Financial Aid Services Office.

Eligibility: All of the following must be met in order to receive consideration for Texas Public Education Grant funds.

1. Meet program requirements.
2. Be in compliance with the SJC Academic Requirements for Receiving Financial Aid.
3. Have been in attendance at San Jacinto College at least one semester as a full-time student on a student visa.
4. Enroll in a degree or certificate program at San Jacinto College during the semester for which a grant is being requested.
